Participation Registration

IDS PRO-Series 2011

With the following registration the driver declares his participation in the IDS Pro series for the season 2011. Besides, a separate registration has to be followed.

The IDS Pro series includes the events listed in Annex A. Besides any other events which are not part of the series must be filed separately or the participation is by invitation by the IDS organization.

For a valid participation the report of the driver's car in point 6 is necessary.

1. Rules and terms of conditions:

The participation accepts the validity of the current regulations and has to attend that the participants' vehicles meet the safety regulations. The rules are published on the website www.driftsports.de or may, on request, be obtained directly from the organizers.

With a valid registration the participant accepts term of the organizer. The terms and conditions are available on the website www.driftsports.de.

The regulations will be overworked periodically and will be published before the start of the season. Technical innovations will be includes in the regulations in case the motor sport, security or attractiveness of the event will be improved.

According to the bonding plan in the regulations, series sponsors will be applied to the participating vehicles. The remaining areas are available for the driver / team. In case the driver should take part in another event with his IDS-branded car, then the IDS organizers have to be informed. In case of an inappropriate advertising, the IDS will decide the fate of the IDS-branding. The driver assures not to acquire any competition sponsors with existing series sponsors. Besides it is not allowed to the driver to contact the existing series sponsors for their own interests.

For the competitions, an expert jury will be available. This may not be from the ranks of current IDS Pro drivers.

2. Registration:

For a valid registration, the participant data in section 4a has to be filled out by the participant and it has to be reported in section 4b. For the 2011 season price money for the first three finishers are proved. For details, see regulations in Appendix H.
